Dear Mr. Sarmiento:

We are in receipt of your letter from March 12, 2021. As you know we represent Woodridge Homeowners Association.

You do not acknowledge receipt of all the documents on the website. In your letter requesting such documents you requested them to be delivered electronically. We do see that the bylaws and CC&Rs are not signed so I am sending copies of those electronically to your email. We are not sure if this is what you meant by inadequate since your request was to have the documents provided electronically and the website provides such delivery.

There is a myriad of documents on the website that are directly responsive to your request for inspection. The website contains minute meetings for the general member meetings from March 4, 2017 until March 7, 2020. Some of those minutes were for special meetings to discuss safety in the community including the fire access roads and fire safety. The website also contains Water Company rates, rules and policies, reports, and information about due process violations as well as the CC&R violation report form. Also on the website are the committee reports from 2020.

The documents that we provided on March 5, 2021 and the documents that are being provided now are documents that were/ are available at the time our response was sent out and were responsive to your request for inspection. We did not nor are we providing an explanation specifically or generally about the ways in which the documents provided match the language used in your request nor are we providing an explanation regarding the availability of documents because this is not within the scope of a request for inspection. The only documents we have withheld are those documents noted above because they are privileged or pertained to specific members. We do admit that there was an oversight on the bylaws that are on the website (because those are not signed and we did not catch that) and the CC&Rs that were in the website and we are providing those with this request. We are also providing the articles of incorporation because those are not available on the website.

Also note that within the documents provided there is a signed contract for Solitude dated March 4, 2021. This contract was signed as we were assembling/scanning/ etc. all documents that were meant to go to you. The decision to sign it was made because if no contracts were in place to provide some form of Lake maintenance that can be performed this year, the Association would lose its place in this year's schedule. This company is the one that is providing a bid for the use of Sonar in the Lake and so that option is still available for the coming years.

Again, I will be sending you complete proposed new governing documents as soon as those are ready.
